

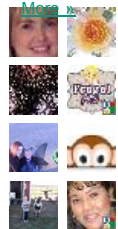

CD/DVD Review - Gustafer Yellowgold's Infinity Sock

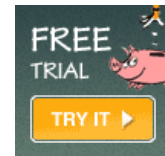


About the CD/DVD

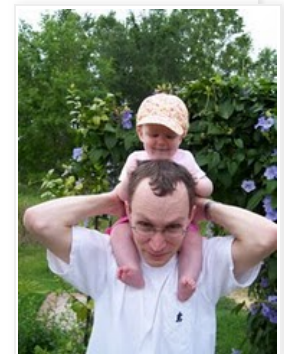
